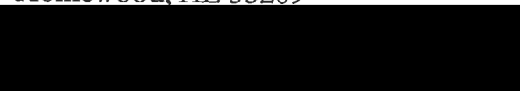
Coordinated multi-jurisdictional "Leadership Luncheon" with approximately 40 participants.

Served as the Union President and built strong Labor/Management relations with the fire administration and the Mayor.

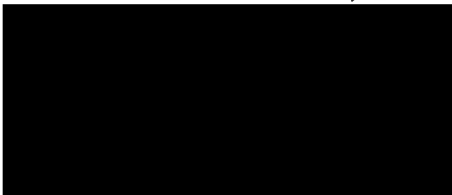
Writes and manages grants for the Homewood Fire & Rescue Service. In 2012, we received SAFER grant for the hiring of 5 new employees totaling \$484,115 and an AFG grant for Vehicle Exhaust Systems totaling \$72,000, and \$414,000 for SCBA's, and a current SAFER grant of \$353,000 which allowed us to add three additional personnel to bring our staffing levels up to the national standard.

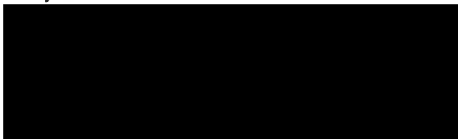
